The Standard of Practice for each certification program is derived from, and/or supports the Fiduciary360 publication: Prudent Practices for Investment Stewards. These Practices are substantiated by legislation, case law and regulatory opinion letters from the Employee Retirement Income Security Act (ERISA), Uniform Prudent Investor Act (UPIA), Uniform

Prudent Management of Institutional Funds Act (UPMIFA) and the Uniform Management of Public Employee Retirement Systems Act (MPERS) in the U.S. All Practice documents are available at www.cefex.org.

The American Society of Pension Professionals and Actuaries (ASPPA) Recordkeeper Standard of Practice describes how a recordkeeper of any size or type can help Plan Sponsors fulfill their fiduciary obligations.

All certifications require annual assessments which use the International Organization for Standardization (ISO) standard ISO 19011: Guideline for Quality System Auditing, which is used by certification bodies throughout the world. Assessments include the collection and review of operational and investment data to substantiate the existence of processes and procedures according to the criteria described in the applicable Standard. On-site visits are conducted to interview key management and verify process implementation.

Assessments are performed by independent, qualified analysts who must subsequently present recommendations for certification to the CEFEX Registration Committee, a group of experts whose objective is to ensure a consistently rigorous evaluation of candidate's adherence to the relevant Standard.
